Application Guidelines

The Membership Application Form:

1. The attached Membership Application is an 'Editable PDF Form'. These means if you are remitting your Membership Fees using EFT (Electronic Funds Transfer); and are willing to submit the form using a 'Digital Signature' then the whole application can be completed online.
2. Otherwise, if you plan to remit the Membership Fees using a Cheque or Money Order then the Membership Application Form can be printed, completed and then mailed along with the remittance to the Club Secretary.
3. What is an 'Digital Signature'? – If you are unfamiliar with the use of 'Digital Signatures' within Electronic Documents visit Wikipedia or the Adobe sites for an explanation.

Membership Period:

1. The Clubs membership period commences on the 1st day of July of each year and terminates on the 30th of June in the following year.
2. Multiple years of membership can be requested by selecting the appropriate fields on the Application Form (Refer to fields marked ⁽¹⁾) and submitting the appropriate Membership Fees.
3. Members that have not renewed their membership by the 31st day of July of their new year will be considered as 'Unfinancial' and therefore shall not be entitled to the privileges of membership.
4. New members joining after the 31st March will be granted the balance of the current year and the entire 12 months of the following financial Year (15 months).
