Treasurer's Report - Sept - Oct 2011

Our Spring Show made a net profit of \$38.73; however, without the generous donations from Don Milham (\$50.00) Jean Rimmer (\$50.00) Ros & Di Cavanagh (\$100.00) and Sharon MacFarlane (\$100.00) totalling \$300.00, this result would not have been possible. So a big vote of thanks to these generous sponsors.

Some fund raising has been occurring behind the scenes, with Rick & myself conducting a raffle for a PP20 type crate. The raffle raised \$95.00. It is proposed to conduct another raffle presently with the major prize being an airline approved PP40 crate, plus 2nd & 3rd prizes, yet to be decided. Additionally, a small chocolate fundraiser is being conducted, and so far the results have been very encouraging, with 33% of sales already achieved in the first month. Projected profit should be ~\$228.00 net. I understand that Marilyn Evans is arranging a Bunnings sausage sizzle; further information on this will be promulgated as it comes to hand.

We have had one response already to the sponsorship of the Classes in Show for Easter 2012. The sponsorships will continue to be promoted through the Newsletter, & hopefully we will have more sponsors come on board. Additionally, I will be approaching a variety of dog-related business etc. to try to obtain some commercial sponsorship.

Overall, it does look like our finances are begin to climb; we need to have that \$2,500.00 balance as the insurance excess safety net, and continue to maintain that.

I would like to extend my personal thanks to all the members who have joined together to assist our financial standing.
