Class Selection & Scheduling

Upgrades:

Adjust your own entry through Top Dog. Upgrades are only accepted up to the close of entry.

Refunds & Running Orders

Refund Policy:

Refunds after close of entry are only available to those who successfully complete Test 10 at a previous trial.

Running Order Policy:

Running orders are determined entirely at the judges' discretion and are final. Decisions regarding run order will not be questioned or subject to dispute.
