DR. G. M. VEVERS AND SOME FAMOUS BULL TERRIERS

NOWN to thousands as the London Zoo's Superintendent since 1923 and to hundreds as the best Secretary the Bull Terrier Club has yet possessed, Dr. Geoffrey Marr Vevers has achieved more than anyone in putting the Bull Terrier on the map.

By his far-seeing, energetic, and successful campaign against deafness, aided by his unrivalled knowledge of animal anatomy, and his firm advocacy of an active, sturdy, low-to-ground type of dog, he has been largely responsible for the greatly increased popularity of the only breed in which he has interested himself.

He owned his first Bull Terrier when he was seven years old. Three champions—International Champion Regent Juno, American Champion Regent Achilles, and Champion Mitsu Dannebrog—have been bred by him in his famous "Regent "kennels. Two dogs—Champion Trafgar Winalot and Champion Cylva Brigade Major—have become champions while in his ownership. Another dog, Regent Pluto, has been the most successful of all modern sires, and few are the notable Bull Terriers whose pedigrees do not include his name. Descended from him, for instance, on both the sire's and dam's side, is the handsome animal shown in the accompanying photograph, the well-known prize-winner Plutocrat of Enderley. Here is a dog after Dr. Vevers' heart—compact, alert, businesslike, and yet of sweet disposition.

Nor does Dr. Vevers consider any reference to his Bull Terriers complete that does not mention Regent Antigone, a charming bitch, who was not only the dam of celebrities, but was a famous prize-winner herself.

Ten years ago Dr. Vevers decided to present to the Bull Terrier Club, for annual competition, a bronze model of the perfect Bull Terrier. But Geoffrey Vevers is thorough in everything he does. The sculptor employed was given access to a hundred photographs, and a score of dogs, chief of whom was Ch. Regent Achilles, but not until he had spent a year in producing a series of models was Dr. Vevers satisfied with the eventual result. That result is to be seen to-day on many a car bonnet, a proud, short-backed, strongly muscled dog whose strength of underjaw is a joy to those old-timers who remember the days when this gentle yet indomitable animal was employed to tackle any living creature, not even excepting lions.

Dr. Vevers is the ideal dog owner. As quiet and business-like as the breed on which he is so great an authority, he never ruins a dog by spoiling him, but pays him the compliment of regarding him as an intelligent, outdoor friend. In this respect he resembles his dog . . . there is no nonsense about either of them.



HENRY COTTON AND "JOHNNIE"

NE of the jolliest Bull Terriers I know is the two-year-old Johnnie owned by Henry Cotton, that good-looking young golfer who has achieved more than anyone in this country in raising the all-round standards of the profession of his choice. It is not too much to say that the game itself has benefited as much from Cotton's precept and teaching as have his brother professionals from his vigorous contention that the labourer is worthy of his hire.

Johnnie, who has no more devoted admirer than Bobby the black-and-white cat, was given to Henry Cotton by Raymond Oppenheimer, the old Oxford golfer, and is typical of the best type of Bull Terrier. As playful and good natured as he is solid and muscular, Johnnie resembles nothing so much as an overgrown baby. So much so that he even sleeps with a doll in his basket, although it is true that in Johnnie's occasional moments of boredom the doll has admittedly lost a limb here and there.


At Ashridge, Cotton's home course, Johnnie thoroughly enjoys going round with his master, and, being one of the best-bred Bull Terriers in the country, behaves in immaculate fashion. Although all other kinds of balls and sticks are the breath of life to him, Johnnie regards a golf ball or club with punctilious respect albeit a wistful eye. He will even cock an ear—the right one—at a shout of "Fore!"

Although Henry Cotton has formerly owned Scottish Terriers and those delightfully glossy black-and-tan Dachshunds, he has so lost his heart to Johnnie's combination of gentleness and strength, allied to almost laughably high spirits, that I cannot visualise him reverting to any other breed. So far as dogs and Henry Cotton are concerned, Johnnie is the best ever.

It is typical of Henry Cotton's distinctive personality that whereas his charmingly situated house at Ashridge is full of good things, not a single golf trophy is anywhere to be seen. Were it not for some formidable bags of clubs in the hall, his might be the house of a successful stockbroker with a weakness for gardening!

It is fitting that this greatest of all British golfers, who has overcome countless health and other difficulties, should find in a Bull Terrier all the qualities he most admires in a dog: courage—reliability—tenacity of purpose; no wonder Henry Cotton and Johnnie please each other as much as they do.

THE LATE SIR HARRY PRESTON AND "SAMBO"

THE late Sir Harry Preston, prince of sportsmen and devoted dog lover, was one of those rare men of whom it can be said with certainty that his personality survives him. Fortunate were those privileged to be acquainted with the more intimate qualities of a man who, when he was nearer eighty than seventy, displayed a virility, a keenness of brain, a readiness of wit, and a gaiety of heart that would have been memorable in one far younger.

From the sturdy age of four years, when he received his first "sock on the nose" from falling over a Bull Terrier sleeping faithfully outside his door, he was never without a dog. For over half a century the breeding of Bull Terriers—"bull-and-terriers" they were in those early days—was his hobby. One there was with such a passion for water that, when he and his master once crossed Blackfriars Bridge on the outside of an omnibus of a vanished era, he leaped from the roof of the 'bus to the bridge, then from the bridge into the Thames, and yet was rescued alive.

But the one Bull Terrier in comparison with whom champions, prize-winners, and all other dogs were but small fry in Sir Harry's eyes was the immortal Sambo. For seventeen years Sambo was his constant and unfailing companion, a shadow who possessed every human quality but speech. Two great gentlemen were these, each a prince of his kind. Although one was but a dog, I know that Sir Harry would ask nothing better of his friends than that in raising a glass to his memory, the name of Sambo should be spoken with his own.

Throughout the whole of not one but several days this remarkable dog would await his master at the front door of the old Royal York Hotel at Brighton, and no stranger, however honeyed his words or tempting the bribe, could lure him from his post. When a journey to London was contemplated, usually with the National Sporting Club as the objective, many were the times when Sambo, who had been last seen at the hotel, was found hiding under the seat of his master's railway carriage; for this white cavalier of a dog boasted a head as well as a heart.

Right well did Sambo know that the hotel dining-room represented Forbidden Territory; yet many were the occasions when he tiptoed (and a Bull Terrier creeping on tiptoe has to be seen to be believed) to the dining-room door and by means of passing underneath a succession of other tables, made his way unseen to his master's table at the far end of the room. Unseen, but not always unfelt; for the old rascal could rarely resist the temptation to announce his arrival by means of a cold, insistent nose pressed against his beloved master's knee.

On one occasion this reluctance of Sambo's to being parted from his master produced alarming, although subsequently amusing, results. The dog had made his usual furtive journey round the room, but varied his usual procedure by pressing his nose, not against his master, but against the leg of a famous but dignified lady who was Sir Harry's guest. The lady broke off in the middle of a sentence and fixed Sir Harry with her eye; he, innocent of offence, talked on. A moment later, the lady laid down her knife and fork and, with rising colour, unmistakably glared at Sir Harry, who, at a loss to understand this sudden change of manner, smiled reassuringly at her. In the next instant his guest, with a stifled cry, rose from her seat. At that moment intuition came to Sir Harry's rescue; he looked beneath the table, produced the culprit, and thus narrowly escaped what he was convinced would have been the indignity of having his ears boxed in his own hotel.

It is often, sometimes all too loosely, said that men grow into the likeness of their dogs. I have yet to meet a more remarkable example of this statement than that provided by this lovable and unique personality. With his indomitable courage, his loyalty, his friendliness, his gentleness, his alertness, his ability in a "scrap" to give the other fellow something to remember, even with his beady little eyes. Sir Harry was the human counterpart of his favourite breed. Indeed, he regarded such a comparison as the highest of all compliments.

It is not surprising that dogs gave Sir Harry unusual devotion. With his sudden joyous gusts of laughter, his eager buoyancy, his twinkly-eyed readiness to poke good-humoured fun, even with his occasional impatience, he seemed at all times and at all ages to be just a lovable little boy.

Not in his own appetites, but in his affection for others lay his enjoyment of life. His was a world of men and women and dogs, rather than of events. A most human, understanding man was he.

Fear In Dogs

- Fear emanates from a very ancient part of the brain and is instinctual, often a fear response is impulsive and is necessary for survival.
- Domestication is the process of reducing the distance required for safety.
- Animals always look at what they are afraid of, pupils are usually dilated, initially
 mouth is closed. Some other physical signs are dry panting, hair loss, leaning backwards, urinating, licking lips, stiff posture.
- Breeders have a vital role to play in socialization of puppies and reducing behavioural issues later on, as the neural pathways are closed at 4 months so it is imperative that breeders do some work on pups to prevent social/fear issues in adult life.
- Fear leads to aggression when dog feels intimidated (the object of fear comes too close or makes eye contact) or the dog feels trapped (eye contact/hugging/loss of personal space)
- There are some excellent DVDs and books on fear in dogs at the Dogs Victoria library, available for members to borrow.

What Dog Owners Need to Know About the FDA's Grain-Free Diet Alert

The <u>FDA launched an investigation</u> into potential links between canine heart disease and diet — specifically grain-free diets. We've compiled the information you need to know to understand this recent development.

What is the FDA Investigating?

It is easy to jump to conclusions anytime we see an FDA headline about pet food. After all, our dog's health is essential to us, and we know that diet can make a big difference in a dog's well-being. We reached out to Dr. Jerry Klein, the Chief Veterinary Officer of the AKC, to hear his thoughts on the investigation.

"The FDA is investigating a potential dietary link between canine dilated cardiomyopathy (DCM) and dogs eating certain grain-free pet foods. The foods of concern are those containing legumes such as peas or lentils, other legume seeds, or potatoes listed as primary ingredients. The FDA began investigating this matter after it received reports of DCM in dogs that had been eating these diets for a period of months to years. DCM itself is not considered rare in dogs, but these reports are unusual because the disease occurred in breeds of dogs not typically prone to the disease." After the advisory, 149 new cases of DCM were reported to the FDA. What is Dilated Cardiomyopathy?

Dilated cardiomyopathy (DCM) is a type of canine heart disease that affects the heart muscle. The hearts of dogs with DCM have a decreased ability to pump blood, which often results in congestive heart failure. Some breeds, especially large and giant breeds, have a predisposition to DCM. These breeds include Doberman Pinschers, Great Danes, Newfoundlands, Irish Wolf-hounds, and Saint Bernards. While DCM is less common in medium and small breeds, English and American Cocker Spaniels are also predisposed to this condition. When early reports from the veterinary cardiology community indicated that recent, atypical cases in breeds like Golden Retrievers, Labrador Retrievers, Whippets, Bulldogs, and Shih Tzus all consistently ate grain alternatives in their diets, the FDA took notice.

Should you be Concerned About Grain-Free Diets?

According to Dr. Klein, "At this time, there is no proof that these ingredients are the cause of DCM in a broader range of dogs, but dog owners should be aware of this alert from the FDA. The FDA continues to work with veterinary cardiologists and veterinary nutritionists to better understand the effect, if any, of grain-free diets on dogs."

In the Dec. 1 version of the <u>Journal of the American Veterinary Medical Association</u>, Lisa M. Freeman, DVM, Ph.D., DACVN, provided an update to the research on DCM and emphasized the issue is not just grain-free diets. She calls the suspected diets "BEG" diets (boutique companies, exotic ingredients, or grain-free diets).

"The apparent link between BEG diets and DCM may be due to ingredients used to replace grains in grain-free diets, such as lentils or chickpeas, but also may be due to other common ingredients commonly found in BEG diets, such as exotic meats, vegetables, and fruits," Freeman wrote. Freeman emphasizes that although there appears to be an association between DCM and BEG diets, the relationship has not yet been proven, and other factors may be equally or more important. As a general rule of thumb, the best thing you can do for your dog's dietary health is to consult your veterinarian, not the internet. Together you can weigh the pros and cons of your dog's diet and if necessary monitor your dog for signs of DCM. Cases of DCM in dogs related to a specific diet can be reported to the FDA via their <u>Safety Reporting Portal</u>.
