Our thoughts are with the Bull Terrier breeders that are dealing with breast cancer. It's a reminder to us all to do regular breast screens.

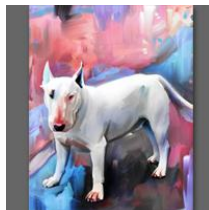
Congratulations to the winners at the recent Canberra shows, it was good to see the Victorian representatives doing so well.

The Influence of the bull terrier on other breeds of dogs

We know what breeds influenced the making of the modern bull terrier, but what do we know about the breeds that the bull terrier has itself influenced?

Presa Canario

The Canary Islands, off the coast of Africa, derive their name from the writings of Pliny the Elder. According to Pliny in his *Natural History*, King Juba II of Mauritania sent an expedition to the then mythical "Fortunate Islands" in 60 AD that returned with a pair of dogs for the king. The expedition found, throughout one island in particular, a breed of large and ferocious dogs and named the island "Canaria" derived from the Latin word for dog "canis." Interestingly, the island known today as Gran Canaria was inhabited by a tribe who called themselves the "canarii." Eventually, all of the islands came to be known as the Canary Islands, the Isles of the Dogs.

The Presa Canario is an ancient molossor breed most likely derived from the now extinct indigenous Bardino Majero. It was originally used for guarding and cattle herding but in the 1800's the breed also became popular for pit fighting, especially in European countries where this was a common and popular entertainment. Breeds were



sought out around the world specifically for their tenacity and endurance, to develop newer and better fighting dogs. Dog fighting was eventually banned in the Canary Islands, but by this time the Presa Canario was nearly extinct in its true form. The situation was not helped by imported dogs, performing many of the Presa's former duties. Along with the mastiff, and bull dog, the bull terrier was one of many dogs used to reconstruct this ancient molossor breed.

Australian Cattle Dog

There have been 'discussions` over the years that the Bull Terrier was used in the initial setting of the type. The heavy muscle and mental toughness required to boss around a bullock twenty times your size are obvious Bull Terrier traits. There are also Blue Heelers today that have heavy fronts, hardly any "stop" on the skull, heavy jaws, and rabbit ears appearing from well-established lines.

The Bull Arab

The Bull Arab is an [Australian dog breed](#) that is bred primarily as a finder and lugger for wild [boar hunting](#). The Bull Arab was developed in the 1970s and started primarily as a [cross](#) between a [Bull Terrier](#), [Greyhound](#), and [Shorthaired Pointer](#). Originally they were 50% [Bull Terrier](#) with the other two parts being German Shorthaired Pointer and [Greyhound](#) however over the years [Bloodhound](#) and English Pointer was added. Some bloodlines have mastiff type breeds too. The desired outcome was a working dog with the power and tenacity of a bull terrier, the speed, height and sight ability of a greyhound and the scenting, intelligence and good nature of the pointer.

While the Bull Arab is not yet an ANKC recognised breed, much work is being done to have the breed registered as it is firmly cemented as Australia's favourite breed of "pig dog".



Guatemalan Bull Terrier (Dogo Guatemalteco) The Guatemalan bull terrier is also called Dogo Guatemalteco and is primarily found in Guatemala. It is called bull terrier mostly because of the influence of the English bull terrier. Other breeds that were used to breed the Guatemalan bull terrier, including the Bull Terrier were the Boxer, Dalmation and Dogue De Bordeaux. As this dog has a combination of different breeds, it shows courage, loyalty, intelligence, endurance, trainability and tenacity. In the 1930s, Hector Montenegro was responsible for breeding and popularizing the dog in Guatemala. Today this dog breed is the official breed of Guatemala. This dog is also a celebrated fighting dog breed in Guatemala. Today the grandson of Montenegro, Dr Antonio Chavez looks after the breeding and registration of this breed in Guatemala. In the US, only the National New and Rare Breed Association registers this breed.

doggies Love Shortenin' Bread

Some veterinarians and animal nutritionists believe that pork fat is the best fat you can feed a dog. Here we have added pork fat not only to induce your dogs to eat the treats, but because it is, some folks believe, good for them.

8 to 10 little loaves or muffins

1 cup yellow corn flour

$\frac{3}{4}$ cup whole-wheat flour

$\frac{1}{2}$ cup bulgur wheat

$1\frac{1}{2}$ teaspoons baking powder

1 cup sour cream

1 cup salt pork, rendered and finely chopped

$\frac{1}{4}$ cup melted pork fat from salt pork

1. Position the rack in the center of the oven and preheat at 375°F. Lightly grease a 9 x $3\frac{5}{8}$ x $2\frac{1}{2}$ -inch muffin pan or little-loaf pan.
2. In a large bowl, using a fork or wire whisk, blend the corn flour, whole-wheat flour, bulgur wheat, and baking powder.
3. In a medium bowl, using a wire whisk or electric mixer on MEDIUM speed, beat the sour cream until softened and smooth. Beat in the pork and fat.
4. Using a large spoon, a spatula, or your hand, combine the two mixes, blending until the dry ingredients are just moistened.
5. Drop 3 heaping tablespoonfuls of the mixture into the cups of the prepared baking pan. Bake for about 15 to 20 minutes or until a golden brown color and a wooden toothpick inserted into the muffins is removed clean.
6. Remove the pan from the oven and cool on a wire rack for 10 to 15 minutes before transferring the muffins or little loaves to the wire rack to cool completely. Drying these muffins or little loaves is not recommended.

WARNING: Pork fat will turn rancid quickly if not kept refrigerated.

YOUR OWN PRESENTATION AND ETIQUETTE

DRESSING FOR THE RING

It goes without saying that you have put much time, thought and effort into the selection of your show dog and his upbringing, care and training. Thus it also should go without saying that you will want to do him justice in the ring.

There is absolutely no logic in a dog that is turned out to perfection while his handler looks like a disheveled mess! While the most acceptable attire for you is likely to differ according to the breed you are showing, you will want to present yourself tidily whatever

A GENTLEMAN'S SPORT

Whether or not your dog wins top honors, showing is a pleasant social event. Sometimes one may meet a troublemaker or nasty exhibitor, but these people should be ignored and forgotten. In the extremely rare case that someone threatens or harasses you or your dog, you can lodge a complaint with the hosting kennel club. This should be done with extreme prudence. Complaints are investigated seriously and should never be filed on a whim.



the breed. This much you owe to your dog.

If you are a lady, high-heeled stiletto shoes would be entirely inappropriate, in part because you may step on your own dog or, worse still, someone else's! You need comfortable shoes that allow you to move well when gaiting your dog for the judge's appraisal. Some exhibitors even go so far as to go barefoot in the ring, but you need not go to such extremes. I don't!

Avoid wearing a lot of dangling or showy jewelry that may distract your dog or perhaps

Always be gracious to the judge, no matter how he places your dog. You never know when you may meet in the ring again.



“TREAT” OTHERS WELL

If yours is a breed that traditionally demands tidbits in the ring, give some consideration to other exhibitors. Restrict the treats to your own dog only, please, and don't throw them too far away from your dog, for this can be very distracting to others.

get caught in his coat. Also, try not to offend the judge and other exhibitors by wearing anything too revealing. It has to be said that some exhibitors select their outfits according to the judge, but this is really an insult to the judge concerned if a lady has chosen to wear a low neckline and tight pants!

Clothes should be comfortable, neat and tidy, and you should choose your outfit to

complement your dog. If you have a black dog, it would be pointless to wear a black suit, for the dog's outline would be completely lost. Instead, wear a contrasting color that sets off your dog to perfection. Also keep in mind that if you wear one color on your lower half and a different color on top, both colors must complement his coat. Should you need to bend down with your dog to present him, neither color must conceal any of the dog's features.

Women should avoid wearing flouncy skirts that will not only flap in the dog's face while he is moving but also will hamper the judge's view of the dog—this is the very last thing you want to do! Gentlemen should remove any loose change from their pockets before going into the ring, because it will rattle and cause distraction.

RING ETIQUETTE

When standing your dog in line for the judge's appraisal at the beginning and end of a class, you clearly want your dog to look his best. In standing your dog, however, please don't overshadow someone else, for this will not be appreciated. You may, though, wish to consider the lie of the land or your dog's coat pattern. Although at some shows and in some countries dogs all have to face the same direction, sometimes it is permissible to stand them facing either direction. In the latter case, if you are in an outdoor

ring and have ended up in a position where the ground slopes, it may be to your advantage to turn your dog around. Likewise, if your dog's coat pattern is more esthetically pleasing on one side of his body, you may want to turn him to show off his best side.

The position of the sun can also be something of a nightmare, especially for the judge. The sun glaring into a dog's eyes can understandably make him squint and can even artificially lighten the color of the eye, so that even a dark eye can appear paler than it actually is. This is another reason that you may wish to alter your dog's direction if this is permissible.

Some exhibitors will insist on taking their female dogs to shows when they are in season, but this is largely frowned upon. A bitch in season is most certainly a cause of distraction for the male dogs. Even if your bitch is not entered in a mixed-sex class, males may follow her into the ring and will try to follow her scent. This means that a male, especially if he is a stud dog, will not give his best performance through no fault of his own.

Whatever placing you have received, never show disgust in the ring. Gone are the days when exhibitors would tear up their award cards in front of the judge. Today such behavior usually carries a heavy penalty. Keep calm at all times, try never to show that

SHOW-RING ETIQUETTE

Just as with anything else, there is a certain etiquette to the show ring that can only be learned through experience. Showing your dog can be quite intimidating to you as a novice when it seems as if everyone else knows what they are doing. You can familiarize yourself with ring procedure beforehand by taking classes to prepare you and your dog for conformation showing and by talking with experienced handlers. When you are in the ring, it is very important to pay attention and listen to the instructions you are given about where to move your dog. Remember, even the most skilled handlers had to start somewhere. Keep it up and you too will become a proficient handler as you gain practice and experience.



you are overly disappointed not to have won and certainly don't complain publicly about the placements.

If you are placed, but not at the head of the line, it is generally considered polite to congratulate the winner briefly before leaving the ring. Always remember that if every judge had the same opinion, there would only ever be one winner! Your turn may come another day. After all, you decided to enter the show for that judge's opinion; if you didn't like the outcome, it is your prerogative not to enter under the same judge on another occasion.

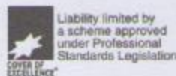


Findings
