MOTIONS OF WHICH NOTICE WAS GIVEN:

S A request for 1985 National Show was transferred to General Business in view of a Victorian request for the same year.

Kidney Disease - A report was received from Mr Wayne Robinson and Mrs Jean Gooding re "Shrunken Kidney". General discussion followed and Mrs Bennett moved a motion that the National Council write to the Small Animals Centre in the U K to try to ascertain which particular lines are carrying the defect, seconded Mrs Richter and carried.

GENERAL BUSINESS:

Change of name - following on information received that the A N K C are discussing the possibility of requesting National Bodies to delete either the word "National" or "Australian" from their title it was resolved to leave the printing of letterheads etc. until a firm decision is made.

Rubber Stamp - in view of the above, it was resolved to have a rubber stamp made "AUSTRALIAN NATIONAL COCKER SPANIEL COUNCIL". Secretary to obtain.

Petty Cash - Mrs Stevens moved that a Petty Cash amount of \$20.00. be made available for the Secretary, seconded Mr Davis and carried.

Next Meeting - to be held on the night of the Cocker Spaniel judging at the Melbourne Royal. It was resolved that if rooms are not available on this night, Secretary to organise a meeting on the night prior and advise clubs to this effect.

First National Show - Two requests to hold a National Show in 1985 were received, one from S A in conjunction with their 30th Anniversary and the other from Victoria in conjunction with Victoria's 150 year celebrations. It was agreed that Victoria hold the first National in March, 1985 in order to obtain maximum publicity for the breed. Moved by B Preston, seconded Mrs Stevens and carried. It was also suggested that S A look to 1987 for their state's 150 year celebrations and N S W consider 1988 when Australia's bi-centenary celebrations will occur.

National Year Book - SA suggested a Year Book to be produced by the Council. Attending members were in agreeance with this idea and Mr Bennett requested clubs to present firm ideas as to concept and printing at the next meeting.
