### BUSINESS ARISING:

U.K. JUDGES

The matter was discussed as per the N.S.W. query and it was resolved that exemptions would be available on U.K. specialist judges if they were not specifically engaged for the show and they paid the majority of their expenses e.g. air fare etc. The exemption would also apply to a judge being obtained for payment of a fee from another club.

CORRESPONDENCE (CONT.) BUSINESS ARISING (cont.)

RAGE SYNDROME The Secretary advised that the last report received on the Rage Syndrome was that it was probably linked to epilipsy and the majority of dogs affected came from the Welsh puppy farmers. It was not a problem here and some vetinarians were quick to blame poor temperament (again mainly in poorly bred dogs) as being the "rage syndrome". P. Little moved the National write to the V.C.A Hereditary Diseases Committee to ascertain the latest information that is available and seek their advice as to how to deal with a public statement if required. Also request that we be updated on information received on the Cocker Spaniel, seconded S. McFadden and carried. It was further suggested that articles should be followed up in the vet. journals.

NOTICE OF MOTION

The notice of motion from the Cocker Spaniel Club of Vic. "that the NCSC(A) seek definition from the Cocker Spaniel Council (U.K.) on the colour "chocolate" was moved by P. Little, seconded S. McFadden and carried.
