BUSINESS ARISING:

CSC of Qld:

Both the President and Secretary have been advised verbally that no minutes or information have been passed on from this Council. It was resolved to review the matter of Queensland's non-participation at the next meeting. An apology was received by the President along with a query as to why no meetings were held in Queensland. The Secretary explained that Annual General Meetings have been held in conjunction with a Championship Show to boost entries and the Constitution specifies that the AGM must be held in the first six months of the year. Queensland hold their Show in August but were asked if they would like to hold a meeting at the National and no reply was received. Meetings have been held in ACT, NSW, SA and Victoria

HD Register:

Member clubs are requested to ask their members for hip results in their club newsletter. The original report and a photo copy to be forwarded to the Secretary who will sight the original and return to the owner. A full list will be then be compiled and forward to all member clubs. Thereafter an addendum to the main list will be published annually. Secretary will email all clubs the up to date listing. The Secretary also reported recent discussions on the internet regarding the publishing of all scores and it was again confirmed that until scoring becomes compulsory only clear/positive results can be recorded because of legal implications.

Secretary requested that when available, the Hip and Eye registers be posted on Club websites as many members were unaware of the registers due to the lack of participation from their own State clubs. It was resloved that this action be taken.

In requesting eye results members to be asked to list the sire and dam as this information is not recorded on most eye examination forms.

2002 and 2004

ACT submitted the attached report on the forthcoming show in September 2002. WA National Shows: have declined to host the 2004 show and it is now confirmed that Victoria will host the 2004 National Show

Code of Ethics/ Secretary advised that all member clubs should check the Code of Ethics and bring it State Requisites: into line with their State requirements. Recently Victoria had to alter the Code of Ethics to conform to VCA requirements. This involved altering Rule 9 by deleting "as registered" as ALL puppies in Victoria have to be sold with a registration certificate and add the word "knowingly" before sell so that Rule 9 read: I will not knowingly sell any dog or bitch which has defects of a nature that is detrimental to the breed.

> Rule 10 has also been altered to combine items a) and b) as Registration Certificate and Pedigree are now combined so Rule 10 reads: I will supply each purchaser with a Certificate of Registration and Pedigree, Immunisation Certificate and a Diet and Care information Sheet.

> Member Clubs to review the Code of Ethics to ascertain that they are in compliance with their State body's requirements and advise this Council of any alteration.
