Judges Listing:

Judges lists have been received from NSW, Victoria and South Australia. There was a query on some of the judges on the NSW list in that they did not have a history with our breed and were not considered "Cocker Specialist" judges i.e. Mr P Olsen, Mr S Pausey, Mrs B Skilton, Mr G Spagnolo, Mr G Vernon. A O'Keefe to make further enquiries and report back.

ELECTIONS:

Miss Donna Daniel is the WA nomination to take the office of President for the forthcoming year. A Scott moved this nomination be accepted, seconded R Kemp and carried.

Secretary - Mrs M Brodie (Vic) was elected unopposed. A Scott moved the nomination be accepted, seconded A O'Keefe and carried.

GENERAL BUSINESS:

Notice of Motion

Vic. Motion:

With reference to the Interim Standard for tails on Cocker spaniels we wish to move a motion as follows:

- 1. That the words after appearance "ideally not reaching below the hock" be deleted.
- 2. The word "well" prior to feathered also be deleted.

After discussion the motion was put to the meeting and lost (2 for, 2 against and 2 abstaining).

NSW Items:

NSW recommends that the affiliation fees be raised immediately to cover the unexpected increase in ANKC annual affiliation fees form \$88 to \$196 and the increased Secretarial cost

NSW suggest that before the next meeting the overall financing of the NCSC(A) be looked at with the view of covering essential costs including the Secretary in the pursuit of her duties

A suggestion is that each affliated club pays a flat fee plus a \$1 per membership (not member). This is a method used by a number of National Breed Councils of about the same size as the NCSC(A). Most seem to pay either \$80 + \$1 or \$100 +\$1.

The issue of Conferlink meetings be revised at the next meeting. NSW will supply all details and costs to the Secretary.

The Secretary expressed concern that member clubs do not know the fundamentals of the National body. If both these issues had been presented in accordance with the rules i.e. at least 90 days before the meeting then all clubs would have had the opportunity to discuss these issues and a decision could have been made at the meeting. Some clubs are also not complying with the time frames requested for decisions etc. Having to chase up information in the week preceding the meeting simply creates additional and unnecessary pressure.

She also explained the Conferlink issue had been raised before and costs and details were forwarded to all member clubs in January 2001. Not one club apart from NSW who raised the matter, commented on the idea. She said that it seemed to be an ideal way to reach a resolution such as the increase in fees without having to wait 12 months until the next Annual General Meeting.

NEXT MEETING: It was resolved that the next meeting be held in conjunction with the Cocker Spaniel Club of Victoria's National Show at the conclusion of judging on Saturday 17 April 2004
