I submit a report on the state of affairs of the National Cocker Spaniel Council (Australia) when the Secretary resigned.

When I was finally able to take possession of the books at the end of June, I was astounded to find no accounting procedures had been completed for over a year. No subscription notice had been forwarded to the clubs and as a result all clubs were unfinancial.

There were also 4 letters of demand for payment of the affiliation fee from the ANKC and a threat of disaffiliation had been issued. This fee was due and payable at the end of February.

The financials had not been audited, indeed had not been touched or prepared at all and therefore did not comply with the Constitution which requires all clubs to have a copy of the audited accounts by the end of March.

At this point I would like to thank the ANKC for the understanding and assistance in this regard.

Unfortunately no hard copies of correspondence have been kept during this time and the meeting scheduled for February had to be abandoned due to inadequate notice. Misinformation was also distributed in relation to the due date for the submission of business for this current meeting and as a consequence some clubs have been unable present their items within the time frame.

In conclusion I would stress that it is extremely important for the continuation of the National, that a suitable person always be nominated for the position of Secretary and wish to put on record that both myself and Judith Balfour will be only too willing to assist if any help is required.
