TREASURER'S REPORT

Financial Year ended 30th September 2024

I present the Audited Accounts and Balance Sheet for the Financial Year ended 30th September 2024 to the Members.

Leaving out the major distortions of the Handbook, overall net figure appears similar to last year. However, closer examination shows that the General account made a loss of \$665.67 – largely offset by a \$462-43 profit in the Handbook account and \$150.00 in Rescue, leaving us with a small deficit for the year.

Fund raising again has been non existent apart from raffles. Our main show raffle fell way short of the previous year because there were very few outsiders to boost ticket sales. Great to have the space to ourselves but not so great for selling raffle tickets! Thank you to all those who contributed to the prizes this year.

With the prospect of an overseas judge on the horizon, we will need some serious action to provide for what is likely to be a very expensive exercise. We need to start **now**, so please bring forward your ideas and let's get started! There simply are not the numbers of dogs around that there once were, and expenses have gone through the roof!

Dog Sports appears to have fared better than it actually did. The cost of sashes from Marellen Show Ribbons \$401.85 is listed under Champion & Open Show instead of Dog Sports on the Balance Sheet. Under Expenses it should read Champion/Open Show \$3,359.75 and Dog Sports should read \$1,480.97. Although not quite breaking even in the year just ended, we are hoping to turn this around in the current financial year with the new Rally classes organised by Amy Butler being well supported.

Members' subscriptions are up slightly from last year, but these figures can be distorted depending on how many pay in September vs October, which is technically the next financial year. We have welcomed some new members but sadly a few of our long time members have chosen not to continue. Again, most of the Chatters being delivered via email has enabled us to avoid any increase in membership fees for now.

The accounts show that the Club is in a sound financial position and should be able to remain so into the future, **provided** we can cover the cost of the future Shows.

AGM report to Oct 2024

In 2022 Zac/Hades came to us due to behaviour problems due to heightened anxiety issues. His owners had vet and behaviour advice from experts and were told that he should be PTS because there was nothing further that they could do. As a last resort the owners contacted us to see if we could take him on. After months of being fostered with Jackie he was taken off his drugs and behaviour was assessed. Zac has problems handing over control to his handler therefore cannot be rid of his anxiety. He was sent to Mark to be assessed, and Mark believes that he isn't bad enough to be PTS but will need to go to a special home that can continue working with him. We finally found Zac the perfect home in July 2024. He is still a handful and anxiety levels are heightened easily but he is the best he will ever be. His new owners will continue to be supported by Mark, and they love him to bits. He has finally got a forever home.

Oct 2023 - Cashew — sable and white (possibly collie X) came to us with behavioural problems due to no training or boundaries given to a youngster. He had been with the breeder to a home, then to the pound, to another home, then to another home before he came to us as a 10 month old puppy. He was boisterous and mouthy. He was placed into foster care with a new fosterer/trainer Monica to be taught some manners. After some time with Monica, he was placed back into Katrina's care. July 2024 he was placed in his new home. I understand Cashew is going great guns with his new family, he's enjoying classes at their local dog club.

Nov 2023 – Baz now Louie – Sable merle. Came to us as a 14 month old puppy surrender. Due to a change in living arrangements of the owner. He had been very loved. He has been the easiest foster for a long time. Adopted Jan 2024. The sweet boy now has a loving active family and Kelpie to look after. He is loving life.

May 2024 – Felix – Rescue gave assistance in trying to get him back to his breeder in Vic. We managed to assist in getting him out of the pound in WA, but due to circumstances he wasn't allowed out of the state. He is safe in a new home in WA.

July 2024 – Eleanor – Border collie. An assist in rehoming a border collie at the request of Jane Armatys QLD rescue. Happily rehomed.
