# Dog Sports Report

*From the 1st of June 2025 to the 31st of July 2025*

June through to the end of August is a busy time in the performance rings. Tracking and Track and Search are in full swing, Scent work which so many dogs enjoy is going gangbusters and Sprint Dog and Lure coursing all take advantage of the cooler weather. Many of our performance judges hold licences across multiple disciplines which does at times lead to bottle necks, and just as in the conformation world we are having a generation of judges stepping down. However, after years of a shortage of those willing to step up there are now more trainees coming through. The current situation does makes things challenging at times.

## AGILITY:

Collies and agility, is all about Nakor (Ch Sunshard Advocate of Illusions JD TK.I SPD SPRD JC) at present. Pauline Wilkins and Juno have had a break, so it's been left to Sir Barks-a-lot to keep the Border Collies on their toes. On the 15<sup>th</sup> of June, Rockhampton hosted one of their combined trial weekends. Nakor and his friend Tully, the other half of team Gingernuts went out to try their luck at the Excellent level. Strategic pairs is often referred to as chaotic pairs, as it can be a bit like that mostly it's do your best and laugh at the mayhem. But no, both boys pulled on their big boy pants and powered around to claim their first Excellent level quali and a first place.

Rockhampton DOC hosted another trial a month later, on the 12<sup>th</sup> of July where Nakor gained a pass in his Excellent Jumping class.

The two roughs were Heather's and Katrina's girls Charlee (Brifferton Dragons Treasure TDX JC SPRD) and Ahsoka (T Gr Ch Sunshard Talk Without Speaking RN TSD CAA SPRD), the smooth was Robyn Neale and her tri girl Vixen (Brifferton Vixen)(*pictured*) who went out for their first venture into the dog world. All three had a great day in spite of the cold, blustery conditions and all three dogs successfully completed their runs to gain points towards their titles.

A week later the ladies were off chasing bags all over the place. In Victoria they were back out at Moora Lure coursing in very chilly weather.
