Financial Year ended 30<sup>th</sup> September 2021

I present the Audited Accounts and Balance Sheet for the Financial Year ended 30<sup>th</sup> September 2021 to the Members.

Once again, a weird financial year with no income to record apart from Members' subscriptions and 54c bank interest from 1<sup>st</sup> October2020 to 3<sup>rd</sup> February 2021, when we were finally able to hold our 2020 AGM. Proceeds of the AGM raffle and a generous donation from Dave Slater accounted for the only other income until payment for Title sashes, in anticipation of presentation at our Championship Show, which subsequently had to be postponed until 3<sup>rd</sup> December, taking it into the next financial year.

There was no activity in the Handbook account apart from \$95.22 interest earned. Likewise, no activity in the Rescue account apart from 37c bank interest and again, a very generous donation from Dave Slater. Thank you, Dave.

Expenses for the year were also minimal, consisting mainly of the usual mandatory payments required to keep the Club afloat. This resulted in a surplus of \$864.02 for the General account and \$300.37 for the Rescue account.

The figures for the next financial year will be interesting with hopefully both the usual and postponed Shows included, and the Dog Sports event.

The accounts show that the Club is in a sound financial position and should be able to remain so into the future.

#### **VICTORIAN COLLIE RESCUE AGM REPORT TO OCT 2021**

Over the Covid19 period we became very quiet. Only one rescue to report.

Gypsy, tri girl, 10 yrs – into care Sept 2021

Gypsy came into foster care from northern country Victoria and was collected for us by Bronwen Cramond at Benalla. Covid lockdown made it tricky to bring this girl to Melbourne for care so Bronwen volunteered her services as foster carer. A beautiful lady through no fault of her own was surrendered to Rescue with no explanation other than "I can't keep her anymore".

Gypsy didn't stay in care for long. After I had made a comment on Facebook that a dog had come into care, one of my previous adopters saw this and contacted me for a chat. Of course, they were a perfect match. So, after prying Gypsy away from her foster carer and organising a covid friendly dog collection point at the Hume Hwy service station, in Euroa. Gypsy came to Melbourne then went off to her new home on trial. She is now a café latte dog living the high life with her new owner Sally.

Thank you to Bronwen for your assistance in finding Gypsy a new forever home. I love it when the collie community come together.

Although he is not a part of the 2021 AGM report I will share the start of a story of another boy that will be on this year's (2022) AGM report. Coby, now Zak, came to us a few weeks ago from Sydney. He was flown down to us for re-educating with the hope that he wouldn't be PTS. After years of the owner and her family trying to correct Zak's anxiety behaviour with training and medication, they finally admitted to themselves that they couldn't help him anymore. After consulting with a well-known behaviourist and trainer in Sydney, they were told to "take him to the vet" to PTS. At her wits end the owner contacted the breeder, then the collie club, who contacted us. After a lengthy conversation with the owner, we decided to take him on.

Next step was consulting our vet on how to get him off his medication. We started reducing the dose. After sitting back and assessing him for a couple of weeks it was decided that he was anxious, but not anymore than we had dealt with before. All he needed was a person (farmer) to bond with that would be around for him all day, and be an only dog so there wouldn't be any competition (resource guarding) anxiety. We have found him the perfect home with a person that knows the collie temperament and was once a foster carer of ours. He had lost his boy earlier in the year so was a perfect home for Zak. Zak is out on trial at the moment with Neil while his meds are being reduced and is so far doing very well. He is the sweetest boy with a loving nature. No need for him to be PTS, only to find a home that suits his needs. We are still

monitoring Zak while he is coming off his meds, and will continue to do so until we are satisfied that he is settled. There will be an update on Zak and how he is tracking in the next AGM report.

This case highlights the need for our breed specific rescue. He needed to be assessed by someone that understands the breed and the difference between a resource guarding nip and an aggressive bite. It also highlights the importance of breeders being available to their new puppy owners, and dogs down the track, so they direct owners to all available options for their dogs if they have problems, or even just directing them to the local obedience club.

This story could have ended very differently for Zak if the owner didn't question.

## Dog Sports Report

For the 1st of August 2021 to the 28th of February 2022.

As everyone knows most of our trialing season over the last two years (as it was with the shows) ended up with events being either endlessly postponed or cancelled. Indeed, the tracking season and the track and search seasons were essentially a wash out. Endurance also went by the way side. But even in the midst of all the lockdowns some of our regional Victorians and Collies in other states still managed to squeeze in a few trials and even titles. Happily, this year has so far, seen a more normal season but unfortunately some trials did not weather the COVID period well and are now lost to us. Most importantly however, our Collies though few in number are mighty in consistency and performance and our little band of trialers grows slowly each year and keeps our breed flag flying.



#### **HERDING:**

Over the weekend of the 10<sup>th</sup> of October while metro Melbourne and parts of regional Victoria were locked down Shelley Donald and her team of Smooths made the trip to Chiltern. Mackie (Ch Foxbell You Fetchem at Orthanc) worked well gaining two passes towards his Started title while his daughter Zandee (Foxbell Fashion Zista at Orthanc) gained her herding instinct test. Even the old grandfather of the piece master Ren (Ch Foxbell First Romance CD RE HNAs) got to play with the sheep helping out as a stock dog to keep the trial running smoothly (pun definitely intended!)

A few weeks later on the 1<sup>st</sup> of November the Aussie Shepherd club finally managed to get a herding trial off the ground and Shelley and Master Mackie ventured off again. This was another successful outing with Mackie (pictured) gaining the final pass he needed for his started title. This makes him Ch Foxbell You Fetchem at Orthanc HSAs

About 6 weeks later, on the 16<sup>th</sup> of January Shelley and Mackie were out playing with sheep and having a great time again. Coming home with two Started Masters passes and a first place in his second run of the day.

A little over a week later on the 23<sup>rd</sup> of January Shelley and Mackie were again off to indulge in their great pleasure yet again. Mackie did a fantastic job and gained two passes only dropping one point in his second run of the day. He also won the high score in trial for sheep, these passes were enough to bring him up to the half way mark towards his Started Masters title.

A month later the VHA held their herding trial, and again Mackie went out there and gained another two passes and another high score in trial. Mackie and Shelley do a great job of promoting Smooths in the herding rings with her boy working well consistently and with excellent scores to go with it.

#### **LURE COURSING:**

On the 29<sup>th</sup> of August in SA, Eva and Inka had a girl's day out when they ventured off to a lure coursing trial where Inka gained the final pass, she needed for her junior courser title. Inka will now be known as Brafferton Incan Sea Treasure CCD TK.S RA JC

Unfortunately, as we sometimes do Karen didn't realise her Dogs SA membership had lapsed over COVID so all the passes and the title Zoe had gained a month earlier were void so back to square one she went. However, I don't think Zoe (Ellerran Carry Me Home) cares very much as it's all down to more fun and games for her! #### **OBEDIENCE:**

On the 5<sup>th</sup> of September, Queenslanders Jackie Christensen and Lilli (Ch Clairescotts Lilli O Th Valley CDX RN TK.N ADX JDX SPD SD HTM.I )gained their first pass in UD. A month or so later at the Nanango Obedience Trial in QLD on the 10<sup>th</sup> of October they set out again and claimed their second UD pass. Pictured.

Then on the 13<sup>th</sup> of November at the Metropolitan dog club's evening obedience trial something happened that doesn't happen very often. A Collie gained it's UD title. Jackie Christensen and Lilli gained the final pass they needed for Lilli's UD title. Lilli will now be known as Ch Clairescotts Lilli O Th Valley UD RN TK.N ADX JDX SPD SD HTM.I

On the 19<sup>th</sup> of December the CCV hosted our second obedience and rally trial. A full report on the trial with photos appeared in a previous chatter. However at this trial we had Amy Butler and Deo (Dual Ch Drambuie Dry and Dirty CCD TD AD JD SD SPD GD) gain a pass in novice which gave her two passes out of the required three for her CD title and my Miko (T.Ch Talcott Hallelujah CD RM TSDX) gained an open pass for the second leg of her CDX title.

#### **RALLY:**

On the 7<sup>th</sup> of August Rocky (Brafferton Black Ice CDX RAE TK.S RM JC) and Eva trotted off to the Para districts double rally trial where master Rocky, had a lovely time socialising and also managed to claim two passes and a second place in his masters class giving him a total of 3 passes out of the 10 required for his Rally obedience champion title.

While a lot of other states found their state trials cancelled last year the Couth Aussia

So over the weekend of the 18<sup>th</sup> of September Eva took both her dogs into the rally section of the state trials and came away with a lovely collection of passes. Rocky gaining two passes in masters towards his Rally Champion and Inka gaining multiple passes in excellent including the final one she needed for her title! Inka will now be known as Brafferton Incan Sea Treasure CCD TK.S RE JC

Again, in SA a few weeks later on the 3<sup>rd</sup> of October on a cold, wet and windy day Eva and her duo spent the day working away at their rally titles. Rocky gained his 6<sup>th</sup> pass out of 10 towards his Rally Champion title while Inka gained two of the double passes required for her RAE title as well as two third places.

Eva and her two Brafferton's also spent New Year's Eve at Gawler's very hot double trial but in the rally rings. Inka, managed two 2<sup>nd</sup> place passes one each in Advanced and Excellent, to give her the third of five legs towards her RAE title.
