6. NOTICES OF MOTION

6.1 Proposed by Nichole Whyte

Moved: Rachel Wright, seconded Denise Ball

“Currently the ruling for our DCWA tattoo regulations, established 1st of August 1991 and last amended 1st of May 2007, reads as follows;

“ it is a condition of membership of the Dobermann Club of Western Australia (Inc) that all puppies born or registered under the Prefix held by a member shall be tattooed with a number issued by the Dobermann Club of WA Inc”

It was proposed that it is amended to;

“it is a condition of membership of the Dobermann Club of Western Australia (Inc) that all puppies born or registered under the Prefix held by a member shall be tattooed with a number issued by the Dobermann Club of WA Inc and/or be microchipped by a registered micro chipper or veterinarian.”

Rationale: At the ANKC October 2010 conference a rule was passed that as at the 1st of January 2012 micro chipping is compulsory across all states of Australia and is enforced by each of the canine association state bodies. This has now been in place for two years, with all requirements processes in place and well established. As such I do not believe there is a requirement for 2 forms of identification, particularly when all Dobermann breeders are not necessarily a member of a state Dobermann club, if there is one in place, i.e. Tasmania, Northern Territory etc. All Local Government pounds, veterinarians and most breeders now have multi chip readers.”

It was proposed the motion be amended to the following:

*“it is a condition of membership of the Dobermann Club of Western Australia (Inc) that all puppies born or registered under the Prefix held by a member ~~shall~~ **may** be tattooed with a number issued by the Dobermann Club of WA Inc and/or be microchipped” ~~by a registered micro chipper or veterinarian.”~~*

The motion was put to vote and passed on the vote of 4 x in favour, 1x against

Moved: Denise Ball, seconded Rachel Wright

Denise Ball spoke *in favour* of the motion based on microchipping being compulsory and therefore tattooing not required

Des presented an email from Paula Brown, Dobermann Rescue *against the motion* due to the number of rescues that have been saved due to the presence of a tattoo and faulty microchips

The motion was put to vote and failed to pass based on the vote of 9 against, 6 in favour, 1x abstained

7. GENERAL BUSINESS

7.1 Graeme Jones enquired as to a date for the next WAE – Des advised him that a suitable time still needs to be confirmed where the committee, evaluator, volunteers and location are all available at the same time.

7.2 Denise Ball raised a query with regards to the Points Score rules and regulations for the 2014 year – in particular Rule 3 “At least one of the registered owner of the Dobermann must be a bona fide resident of Western Australia and the resident owner(s) within 100km radius of Perth must have assisted the Club in the organisation and or running of at least one event in that competition year. (amended 2005 & 2006)” This rule is currently not being enforced and Denise requested that more information be made publicly available through the facebook sight, website and Tailless Times to enable the rule to be enforced from 2014 forwards.
