Criteria for Australian Specialist Judges to be placed on the ROM list are as follows:

The criteria in the ROM Rules – ROM Rules 4g. -

1. ANKC Championship Show approved judges who are current breeders of Bull Terriers and or Bull Terrier (Miniature) with a demonstrable involvement in the breed/s over a period of not less than ten years.
2. ANKC Championship Show approved judges who, although not current breeders, have bred or owned Bull Terrier and or Bull Terrier (Miniature) for not less than ten years and retain close association with the breed/s and have demonstrated an abiding interest and close recent involvement with the breed/s
3. ANKC Championship Show approved judges must have bred a minimum of 5 litters of Bull Terrier and/or Bull Terrier (Miniature). Litters must be registered in the applicant's prefix. (BTCSA NOM 10Oct25)
4. ANKC Championship Show approved judges must have owned and/or co-owned 5 Bull Terrier and/or Bull Terrier (Miniature) to a Conformation Championship title. (BTCSA NOM 10Oct25)
