Proposed Motion

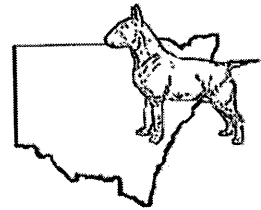
That the Secretary and /or President of National Bull Council Australia may not vote on any issues raised whilst they attend the National Breed Council Meetings at ANKC.

Rationale

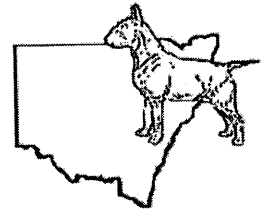
For the Australian Trophy Show to have any credibility all member clubs of NBTCA must be allocated a show.

Proposed Motion

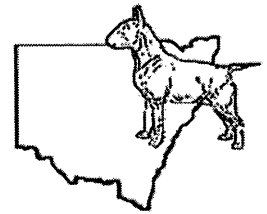
That any judges whose ROM status has not previously been established by NBTC, be accepted or declined by a vote from NBTC member clubs.

The prospective judges resume is to be provided by the inviting club to NBTC, it is then to be circulated to member clubs by NBTC secretary. Armed with this information they are more than qualified to make a decision in a timely fashion.

Rationale.

It is not the role of the Secretary of NBTC to decide whether a judge is eligible to award ROM points. This has been the practise, and is not acceptable and places an unfair burden on the secretary. The secretary's role is to provide the ROM cards to clubs and record the results. Club members have enough experience to decide if a judge qualifies or not.

For Bull Terrier clubs holding a show with ROM points allocated,
That half ROM points only be awarded to an entry of 20 or less animals per sex. Eg. If there are less than 20 dogs only half normal ROM points be awarded. For an entry of 20 or more per sex full ROM points be awarded. Absent animals are to deducted from the number, as per Challenge.

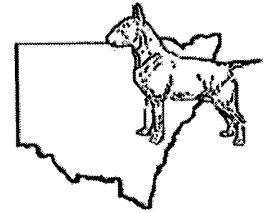
) This is to apply to Bull Terriers only as Bull Terrier Miniature numbers are still much lower.

The ROM scheme was originally established to reward the top dogs. To make this a worthy award it should be hard to obtain.

Why should a dog that wins a show with a total entry of for eg 40 be awarded the same points as a dog that beats 100.

That Bull Terrier clubs are to cater for the Bull Terrier Miniature in all club activities.

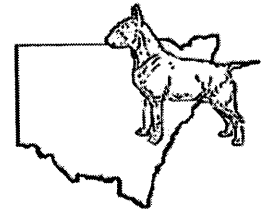
The Trophy show is conducted under State and ANKC regulations and must therefore cater for Bull Terriers Miniature.

Proposed motion.

That current member clubs of NBTC that do not comply with NBTC constitution be immediately suspended, until such time as they comply.

Rationale

If we are to have a constitution we have to abide by it and not just choose those bits we like. The only outcome can be that member clubs comply with item 1.2 as the item cannot be removed or altered as it would then not comply with ANKC regulations.

Legal advice on the wording of this item concludes that only clubs catering exclusively for the above breeds shall be eligible for membership. Is self explanatory. And that clubs not catering for both Bull Terrier and Bull Terrier Miniature are not eligible for membership.

This needs to be addressed immediately as clubs that have proposed motions and voted on them that are in fact not eligible for membership. These motions must be declared null and void.

1.2 The Breeds referred to in this constitution and by-laws are the breeds which are internationally known as the 'Bull Terrier' and 'Bull Terrier (Miniature)'. Only clubs catering exclusively for the above breeds shall be eligible for membership. Throughout this document the term 'Bull Terrier' refers to both the Bull Terrier and the Bull Terrier (Miniature).
