**1. MEMBERSHIP FEES:**

~~(A) If persons join between the first day of September and the last day of February, the following Membership fees apply:~~

- ~~— Single Membership — \$26.00~~
- ~~— Dual Membership — \$30.00~~
- ~~— Joining Fee — \$ 5.00 (New Members/ Lapsed Members)~~

~~(B) If joining between the first day of March and the last day of August, the following Membership fees apply:~~

- ~~— Single Membership — \$14.00~~
- ~~— Dual Membership — \$16.00~~
- ~~— Joining Fee — \$ 5.00~~

~~(C) Breeders sponsoring membership for puppy purchasers for all pups in one litter will receive a per person \$10 membership reduction for 12 month membership, \$5 reduction for half year memberships.~~

- ~~a) Membership Fees will be determined at the Annual General Meeting each year and will be for the financial year from 1<sup>st</sup> September to 31<sup>st</sup> August. (Refer to RRCV Rules of the Association Rule 5)~~
- ~~b) If persons join between 1<sup>st</sup> September and the 31<sup>st</sup> May, a full year's membership fee will apply.~~
- ~~c) If joining between the 1<sup>st</sup> June and 31<sup>st</sup> August, a full year's membership fee will apply and membership will be for 15 months, ie up to 31<sup>st</sup> August the following year.~~
- ~~d) No joining fee will apply.~~
- ~~e) Where Member Breeders sponsor membership for puppy purchasers for all pups in one litter, the new member will receive a complimentary 12 month membership (as per 1a) to 1c) above).~~

~~a) -The Annual General Meeting of Members shall be held in the month of October in each year and Members shall be given notice, in writing or by electronic transmission, at least fourteen days prior to such meeting. ~~Proof of posting the notice shall be deemed sufficient notification.~~~~

~~b) -The President of the Club shall be the Chairman at all General Meetings. Should they not be present within ten minutes after the time appointed for holding the meeting, then one of the Vice-Presidents shall be elected to the Chair by the members present, and if no Vice-President be present, the Members shall elect one of the Members of the Committee to take the Chair. If at any General Meeting there is no quorum within thirty minutes of the time appointed for the meeting, then the meeting shall lapse.~~

#### 8. PROPERTY CLASSES:

*BRACE* – Two exhibits six months of age or over, each of which has competed in at least one ordinary class at the same exhibition, is the property of the same owner and is handled in the judging ring by the same person.

*BEST HEADED DOG/BEST HEADED BITCH* – This class is to be judged on the interpretation of the head as per the standard.

*BEST GAITED DOG/BEST GAITED BITCH* – This class is to be judged on the interpretation of the gait as per the standard.

*BEST RIDGED DOG/BEST RIDGED BITCH* – This class is to be judged on the definition of the ridge as per the standard.

*BEST RIDGE OVERALL* – The Best Ridged Dog and the Best Ridged Bitch will be judged together and the best ridge will be determined as per the standard.

*SIRE ~~AND'S~~ PROGENY/DAM ~~AND'S~~ PROGENY* – The Sire and Dam are not required to be in the ring. There ~~can~~ must be a minimum of two progeny and a maximum of five progeny from at least two litters, permitted in the ring. This class is judged on the —uniformity of the progeny as per the standard. Baby puppies are not allowed to enter as progeny.

*BEST BROWN NOSE* – This class is limited to brown nosed ridgebacks and is to be judged on the overall quality of the animal (dog or bitch) as per the standard.

*NEUTERED* – This class is open to any dog or bitch that is desexed and on a full register and is desexed the ANKC Neuter Register.

*PARADE OF VETERANS* – This class is not judged as a class but is a parade of exhibits seven years and older.
