



## **Schnauzer Club of NSW Inc Championship Show 11 October 2020**

### **CONDITIONS OF ENTRY – COVID -19 Safety Plan**

**Every attendee (this includes designated handlers) must read and familiarise themselves with the information detailed in this plan.**

**Attendance at our Show implies having read, understood and agreed to comply with ALL requirements as documented.**

**These conditions commence upon your entry through the entry gates into DOGSNSW premises.**

**You are required to leave DOGS NSW premises within 1 hour of the Shows closure.**

<b>Item</b>	<b>Requirement:</b>
1	If you have even mild symptoms please stay at home and get tested. Attendees are encouraged to download the COVIDSafe app @ <a href="https://www.health.gov.au/resources/apps-and-tools/covidsafe-app">https://www.health.gov.au/resources/apps-and-tools/covidsafe-app</a>
2	Entries are restricted to residents of NSW and ACT only.
3	Visitors shall not be permitted to attend this event. A visitor is deemed to be a person who does not own an exhibit entered at the event or is not a member of the household of an entered exhibitor or a Designated (or regular) handler (A designated handler is a person who has an established relationship with an exhibitor and has a prior agreement to handle dog (s) if required)
4	Entry will only be available through the online entries system -no paper entries

5	Failure to adhere to any instruction issued by an Official or Covid 19 Marshall shall result in the exhibitor being required to immediately leave the grounds and they shall be subject to disciplinary action by the relevant authorities.
6	The marked catalogue shall serve as a record of attendees for purposes of contact tracing. Other persons /members of the household/designated handlers will need register with Show Secretary
7	A record of officials and staff present at the event shall be maintained by the Show Secretary.
8	Catalogue will be provided electronically prior to the commencement of the show
9	Exhibit card numbers shall be emailed to exhibitors.
10	It shall be the responsibility of the exhibitor to print their own exhibit numbers.
11	For exhibitors unable to print numbers they shall obtain same from the Show secretary.
12	There shall be NO setting up of any exhibitor equipment prior to 9.00am on the day of the Show.
13	Gazebos must be spaced a minimum of 1.5 metres apart. Only members of the same household and pre-designated handlers shall share a gazebo.
14	There shall be no congregating or setting up under the ring awnings.
15	Keep a distance of 1.5 metres between yourself and other people.
16	Do not shake hands, hug or kiss as a greeting.
17	Practise good hygiene by cleaning your hands thoroughly for at least 20 seconds with soap and water, or sanitizer, after visiting a common area, or after blowing your nose, coughing, or sneezing.
18	No person shall encroach into the Steward's designated safety zone. Area to be taped.
19	Masks may be worn by Officials and Exhibitors- but are not compulsory, however NSW Dept of Health regulations may change. (Masks are available from Show Secretary at minimal cost)
20	Hand sanitiser shall be available, exhibitors are also encouraged to provide their own. Hand Sanitiser to be purchased by Schnauzer Club NSW Inc for use.
21	Exhibitors are required to wipe their dog leads with sanitizer wipes when other persons, including designated handlers, handle the dog(s)
22	All Venders and Patrons shall adhere to physical distancing rules.
23	Exhibitors shall avoid touching dogs that are not their responsibility.
24	Exhibitors and Officials shall not use common pens & pencils or tables and chairs.
25	Exhibitors shall enter the ring area via the entrance and depart via the exit maintaining physical distancing at all times. Signage and taped markings required will be completed prior to event.
26	Exhibitors are requested to be considerate of fellow exhibitors and maintain appropriate hygiene and physical distancing when visiting restrooms.
27	Exhibitors are reminded that food and drinks are not to be shared between other persons at Show.
28	Exhibitors shall stand at arm's-length from their exhibit if practicable as it is being examined by the Judge. (This will assist in providing the requisite 1.5 metre physical distancing.)
29	The exhibitor shall be responsible for mouthing the exhibit. Judges are encouraged to examine exhibits at arms-length to facilitate physical distancing.
30	Where there is more than one entry in a class, exhibitors must adhere to physical distancing rules.
31	Judges must wash/sanitise their hands between each exhibit.
